OSU Foundation - JT Thomas

Please help spread the word about the CASE Advancement Internship Program. CASE is pleased to partner with institutions globally for the 2022 CASE Advancement Internship, providing more than 100 interns the opportunity to gain hands-on education advancement experience while exploring the profession. Since inception in 2016, more than 450 undergraduate students, grad students and recent grads have gone through the program, in which many are now working in advancement positions at institutions including Columbia University, Drexel University, Emory University, The Ohio State University, Michigan State University, Pennsylvania State University, Washington State University, and University of California, Berkeley. This internship is now open to students in Europe and Latin America. Applicants will only be considered by host institutions in the country they reside.

Applicants will have the opportunity to go into their application to select institutions they'd like to have receive their materials throughout the open period. Most institutions offer a \$5,000 US stipends or hourly wage for the CASE Advancement Internship. (Other regions to be determined). Please note: CASE does not provide visa/sponsorship assistance.

The first meeting of the CEOAS college diversity committee was held in January. Currently, we are reviewing some existing recommendations from graduate students and other groups, plus also working on long term DEI strategic plan for the college.

College of Public Health and Human Services – Kate MacTavish

We received news that Oregon State University is one of seven institutions nationwide to receive a new grant from the Robert Wood Johnson Foundation for the purpose of creating and implementing reforms that make public health academic programs more equitable. The 18-month "Transforming Academia for Equity" grant allocates \$300,000 to OSU's College of Public Health and Human Sciences. Jonathan Garcia, Associate Professor on Global Health is the PI, and Kate MacTavish, Associate Professor in HDFS is the Co-PI.

Office of Institutional Diversity – Teresita Alvarez-Cortez

The National Conference on Race and Ethnicity (NCORE) will be held in Portland at the Oregon Convention Center from May 31-June 4, 2022. NCORE is significant and prominent national forum on issues of race and ethnicity in American higher education. The Office of Institutional Diversity is sponsoring registration scholarships to support university employees seeking to attend the 2022 National Conference on Race and Ethnicity (NCORE). Early bird conference registration is \$625. Applicants may apply for a full or partial registration scholarship. Scholarship recipients will be responsible for all other conference fees, including travel expenses and pre-conference institutes, if desired. Preference will be given to employees who seek to attend because of relevant equity position responsibilities or development benefitting their research.
